FLINDERS SHIRE COUNCIL (MAKING OF LOCAL LAW) NOTICE (NO. 1) 2015

Title

1. This notice may be cited as *Flinders Shire Council (Making of Local Law) Notice (No. 1) 2015*.

Commencement

2. This notice commences on the date of gazettal notice.

Making of local laws

3. Flinders Shire Council has, by resolution dated the 20th day of August 2015, made—
(a) each local law identified in schedule 1, column 1; and
(b) each subordinate local law identified in schedule 1, column 2.

Local law that authorises a subordinate law to be made

4. The local law which authorises each subordinate local law identified in schedule 1, column 2 to be made is identified in the corresponding part of schedule 1, column 3.

Local law that repeals a local law

5. Each local law which is repealed by a local law is identified in schedule 1, column 4.

**NOTICE OF ADOPTION OF MINOR AND ADMINISTRATIVE
AMENDMENTS TO *BRISBANE CITY PLAN 2014***

At its meeting on 1 September 2015, Council adopted minor and administrative amendments to *Brisbane City Plan 2014* including the Infrastructure design planning scheme policy (SC6.16). The amendments apply to the planning scheme area of the Brisbane City Council and will commence on **4 September 2015**.

Purpose and General Effect

The amendments are intended to align the planning scheme and planning scheme policies with recent development approvals, adjust references, refine terminology and reflect specific Queensland Government mapping.
