Notice of adoption of an amendment to the Transport, access, parking and servicing planning scheme policy that supports the Brisbane City Plan 2014 pursuant to Section 22 of the Planning Act 2016 and Section 5.2 of Part 1 of Chapter 3 and Schedule 5 of the Minister's Guidelines and Rules made under Section 17 of the Planning Act 2016.

At its meeting on 19 November 2019, Brisbane City Council adopted an amendment to the Transport, access, parking and servicing planning scheme policy that supports the Brisbane City Plan 2014 to include increased car parking for suburban multiple dwellings amendment (Amendment package J). The amendments apply city-wide and will commence on 29 November 2019.

Purpose and General Effect

The amendment increases the amount of car parking required to ensure multiple dwellings in suburban areas provide sufficient on-site car parking spaces to accommodate parking demand.
