At its meeting on 19 November 2019, Brisbane City Council adopted amendments to *Brisbane City Plan 2014* to identify and protect local heritage places, buildings constructed prior to 1911 and key civic spaces and iconic vistas (Major amendment package F). The amendments apply city-wide and will commence on **29 November 2019**.

**Purpose and General Effect**

The amendments are intended to:

- maintain and enhance Brisbane's heritage by including new local heritage places and heritage adjoining properties and updating existing heritage places on the Heritage overlay
- protect more of Brisbane's buildings constructed prior to 1911, by the addition of new sites to the Pre-1911 building overlay
- recognise Brisbane's key civic spaces and iconic vistas by including a new Key civic space and iconic vista overlay code and map.

At its meeting on 22 October 2019, Brisbane City Council adopted amendments to *Brisbane City Plan 2014* (City Plan) to include major amendments. The amendments apply city-wide and will commence on **29 November 2019**.

**Purpose and General Effect**

The proposed amendments are intended to:

- ensure that City Plan remains effective and up-to-date
- protect the city's most important habitat and remnant bushland
- identify Brisbane's main ecological corridors and incorporate significant koala habitat areas
- refine mapping of the biodiversity areas overlay
- incorporate Queensland Government mapping
- change the categories in the mapping
- refine and amend biodiversity-related provisions of City Plan.
